



MANAGEMENT SYSTEM POLICY

Planta de Regasificación de Sagunto, S.A. (SAGGAS) is the company that owns the natural gas regasification plant located in the port of Sagunto and the transportation pipeline that connects it to the Gas System Transportation Network. SAGGAS is in charge of managing the commercial operation and maintenance of the regasification plant. As an integral part of the energy sector, SAGGAS aspires to improve its global performance and provide a solid base to develop **Sustainable Development, Energy and Climate Change Initiatives**.

SAGGAS considers **Safety, Human Resources Management, Service Quality, Environmental Protection, Energy Performance, Management Control, Asset Management and Innovation and Improvement as Strategic Pillars of its business development**.

SAGGAS Board of Directors has the power to approve the general policies and strategies of the Company.

For all these reasons, SAGGAS has defined the following Management Policy:

MANAGEMENT CONTROL

SAGGAS Management assumes the commitment of leadership in the integral and priority management of the Strategic Pillars, setting improvement objectives and periodically reviewing the Management System, Programs and Results, being committed to a model of continuous improvement.

The necessary resources and training are provided to enable employees to perform their duties with due guarantees of safety, to carry out their activities taking into account the most appropriate criteria to ensure respect for the environment, to make efficient use of energy and to meet the needs and expectations of the Stakeholders.

At SAGGAS, each employee is responsible for his/her own safety and that of others.

PROCESS CONTROL

SAGGAS guarantees quality in all its processes and is committed to continuously improve them, identifying, evaluating and managing Risks and Opportunities. SAGGAS defines and systematically reviews the objectives and ensures:

Compliance with current legislation in general and in particular on environmental management, safety and prevention of serious accidents, energy use and consumption and energy efficiency, taking into account future legislative developments in the planning of its activities, as well as other requirements to be subscribed.

The detailed analysis of the processes, studying the substances involved, energy consumption as well as facilities and procedures, eliminating hazards and minimizing risks to the safety and health of employees, preventing pollution and improving environmental working conditions, promoting the efficient use of natural resources and promoting practices of reduction, reuse and recycling of waste. Special attention is taken to the modifications that could be carried out in the facility, such as new projects, expansions, changes in specifications, etc.

The promotion of research, participating in those initiatives that value the use of natural gas as a key energy source for energy security, environmental sustainability and accessibility.

The development and use of efficient and safe technologies in all processes, taking into account the best available techniques provided by technological development at all times.

The acquisition of **energy efficient products and services**.

The maintenance of facilities and the performance of periodic checks, taking as a starting point those established by current regulations and manufacturers' recommendations, aimed at obtaining **high availability and reliability** of Saggas' assets, **with cost optimization**.

DEVELOPMENT OF THE HUMAN FACTOR

SAGGAS encourages the consultation and participation of all its staff in the corporate culture and policy. To this end, the necessary means are established to ensure fluid communication and a permanent exchange of information between the Stakeholders to communicate the applicable procedures and requirements, and to coordinate and supervise their activities in order to achieve the highest levels of quality, safety, environmental protection and efficient use of energy.

SAGGAS Management maintains and promotes a commitment to continuous training with all its employees. One of the objectives of this Policy is to have a qualified, sensitized and highly specialized human team in all Saggas processes in general, and in those aspects related to the efficient use of energy, risk prevention and action in the event of possible emergency situations in particular.

CONTINUOUS IMPROVEMENT

Saggas is committed to the analysis and continuous improvement of its processes with the aim of reducing risks, detecting any risks or deviations that may occur, investigating the causes that produce them and implementing the appropriate prevention and action mechanisms for each situation.

The implementation of this Policy guarantees a high level of protection of human health, the environment and property, being proportional to the dangers of serious accidents at SAGGAS. Likewise, this policy commits all its staff to improving the control of major accident hazards on a permanent and continuous basis and guarantees a level of protection.

The promotion and assumption of the values described in this Policy is the best investment to achieve excellence in the activity of SAGGAS.
